What type of insurance is this?

Our product provides event ticket insurance and offers to individuals the following benefits:



What is insured?

Ticket Cancellation

Which events are insured?

- ✓ Death;
- ✓ Injury;
- ✓ Unexpected serious illness
- ✓ Individual quarantine
- ✓ Legal proceeding on the day of the event

What will be reimbursed?

- ✓ Amount of the ticket cancellation fees not refundable
- ✓ Sum insured: according to the premium booked



What is not insured?

Applicable to all coverages:

- ✗ Existing illnesses that are not unexpected and were last treated prior to taking out the insurance or respectively to booking the event
- ✗ Event tickets that have not been purchased from the authorized ticket seller



Are there any restrictions on cover?

- ! War or acts of war
- ! Civil disorder or unrest, except when and to the extent that civil disorder or unrest is expressly referenced in the insured covers
- ! Terrorist events, except when and to the extent that terrorist events are expressly referenced in the insured covers
- ! Your intentional self-harm or if you attempt or commit suicide
- ! Non-stabilized pre-existing medical conditions
- ! Air, water or other pollution
- ! Natural disaster, except when and to the extent that a natural disaster is expressly referenced in the insured covers
- ! The consumption of alcohol or drugs not medically prescribed



Where am I covered?

Event Ticket Cancellation applies to the event ticket booked. The event ticket cancellation insurance covers the insured persons of the purchased tickets.



What are my obligations?

To avoid the policy being cancelled and claims being reduced or refused, you must:

When joining the group insurance contract

- Provide us with relevant, true and complete information allowing us to confirm coverage;
- Provide us with supporting documents when requested;
- Pay the premium;
- Read the insurance information carefully to ensure that it provides the cover needed and that all applicable conditions are understood.

Once the coverage is in effect

- Tell us as soon as possible of any changes that arise and that may affect the cover;
- Take reasonable care to protect yourself and your property against accident, injury, loss and damage and to minimize any claim.

In the event of a claim

- Contact us to make the claim immediately after an event arises, in concordance with the insurance information and conditions and provide us with all supporting documents enabling to process the claim;



When and how do I pay?

Premium is paid at the time of entering the group insurance contract.



When does the cover start and end?

The ticket cancellation coverage begins on the date indicated in the confirmation of the coverage and ends with the start of the event.



How do I cancel the contract?

- Withdrawal – the insurance contract may be terminated within 14 days from the time of issue/receipt of the insurance document without obligation to state the reasons and without penalty.
- Termination – after the expiry of the 14-day period, the insurance contract may be terminated at any time, but the Insurer shall not refund the premium paid.
